Wedding Photography Agreement

This agreement between Ice and Fire Photography (hereinafter "Photographer") and _____ and _____ (hereinafter "Clients") relating to the Clients wedding, which will take place as described in wedding planner.

Exclusive Photographer

The clients agree the Ice and Fire Photography will furnish photographic coverage on the above date. The photographer will be the exclusive professional photographer retained by the Clients for the purpose of photographing the wedding. Family and friends of the Clients are welcome to photograph the wedding as long as they do not interfere with the Photographers duties. The Clients reserve the right to retain the services of a videographer to cover the wedding, if they so choose.

Reservation Deposit and Payment Schedule

Upon signature, the Photographer reserves the time and date agreed upon, and will NOT make other reservations for that time and date. For this reason, the Reservation Deposit of \$300.00 is non-refundable, even if date is changed or wedding cancelled for any reason, including acts of God, fire, strike, extreme weather. Reservation Deposit is to be paid at time of Clients signing this Contract. The Reservation Deposit is applied towards the contracted order upon completion of this Contract. Client understands and agrees that the entire amount owed for the wedding photography package described in the Wedding Package Agreement is due no later than seven days before the Wedding Day. Client agrees without balance paid by this time, the photographer will NOT photograph the Wedding Day described on this contract with no liability to Photographer and loss of Reservation Deposit by Client.

Pre-Event Schedule

The Client agree to a pre-event consultation two to three weeks before the Wedding Day in order to finalize the actual shooting times, locations, and other details or concerns of the Clients.

Limitation of Liability

While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, the Photographer's entire liability to the Clients for any claim or loss arising from the Photographer's performance is limited to a return of all money paid by the client. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunctions, lost in mail, or otherwise lost or damaged without fault on the part of the Photographer. Because a wedding is an uncontrolled event, the Photographer cannot guarantee delivery of any specifically requested image(s).

Responsibilities

The photographer is not responsible for compromised coverage due to causes beyond the control of the Photographers including but not limited to obtrusive guests, lateness of the clients or guests, weather conditions, schedule complications, incorrect addresses provided to the Photographers, rendering of decorations, or restrictions of the locations. The Photographer is not responsible for backgrounds or lighting conditions, which may negatively impact or restrict the photo coverage. The Photographer is not held liable for missed coverage of any part, person or object of the wedding. The Photographer is limited by the rules and guidelines of the location(s) and site management.

Safety

The Photographer reserves the right to terminate coverage and leave the location of the Wedding if the Photographer experiences inappropriate, threatening, hostile or offensive behavior from person(s) at the Wedding; or in the event that the safety of the photographer is in question.

Permits

The client is responsible for acquiring all permits and necessary permission for all locations on which the Photographer will be performing services.

Shooting Time/Additions

The Client and Photographer agree that cooperation and punctuality are essential to accomplish the goals and wishes of all parties. Shooting commences at the scheduled start time and ends at the scheduled end time. If the Client does not arrive at the appointed time for the Wedding, shooting will commence at the scheduled start time and end that the scheduled end time. All additional time beyond the scheduled time will be billed to the Client.

Display Promotion

Clients agree that the Photographer may display and use images from the wedding day for advertising, display, website and internet promotion, photographic contests, bridal shows, public displays as in malls, photography books, store fronts, window displays, studio displays, and any other purposes thought proper by the photographer.

Expenses

When applicable, the Client is responsible for all travel, accommodation, meal and transport costs unless provided by the Client. All travel expenses are based on the distance between the Wedding location and the Photographers address. For all events, weddings, the first ___km round trip of travel are included. All miles in excess of ___ km round trip are charged \$_. per km. Meals will be provided by the Clients, or Photographers will require a half hour break on or off property to eat on the expense of the Client.

Photographs

The Photographers will provide the Clients with the edited, jpeg images on a USB. The Photographers do NOT give raw, un-edited photos at any time. The Photographers are not liable

to deliver every image taken at the wedding. The final postproduction and editing styles, effects, and overall look of the images are left to the discretion of the Photographers. The Photographers will present the Clients photographs no later than 4(four) week after the wedding and have an online gallery on Pass and the Photographers website.

This contract incorporates the entire understanding of the Clients and the Photographers, and the Clients and Photographers agree to all its terms, and acknowledge receipt of a completed copy of the Contract signed by all parties. Any modifications of this contract must be in writing and signed by all parties. Each person signing, as Clients below will be fully responsible for payment is made pursuant to the terms of this agreement.
